The Assistant Director-General for Education was responsible to the Director-General for the leadership of the largest of UNESCO's five programme sectors, which are Education, Science, Culture, Social/Human Sciences and Communications/Information.
Working out of UNESCO's headquarters in Paris, the Assistant Director-General for Education led staff based there and in field offices and institutes around the world. The sector's mandate covered all levels of education and training – both formal and informal.
Its central priority was to be the catalyst, within the international community, for progress toward the goals of *Education for All* that were agreed at the World Forum held in Dakar in April 2000. These are:
- ▶ *Expand and improve comprehensive early childhood care and education, especially for the most vulnerable and disadvantaged children.*
 - ▶ *Ensure that by 2015 all children, especially girls, children in difficult circumstances, and from ethnic minorities have access to and complete free and compulsory primary education of good quality.*
 - ▶ *Ensure that the learning needs of all young people are met through equitable access to appropriate learning and life skills programmes.*
 - ▶ *Achieve a 50 per cent improvement in levels of adult literacy by 2015, especially for women as well as equitable access to basic and continuing education for adults.*
 - ▶ *Eliminate gender disparities in primary and secondary education by 2005 and achieve gender equality by 2015 – with a special focus on ensuring full and equal access for girls to basic education of good quality.*
 - ▶ *Improve all aspects of the quality of education to achieve recognised and measurable learning outcomes for all – especially in literacy, numeracy and essential life skills.*
